St. Lawrence County-Industrial Development Agency

CHAPTER 358

An Act to antend the general municipal law, in relation to creating and establishing the St. Lawrence county industrial development agency, and providing for its functions, powers and duties.

Approved and effective June 1, 1971.

Passed on home rule request: See Const. art. 1X, 1 2(b) (1), and McKinnoy's Legislative Law [4].

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The general municipal law is hereby amended by inserting in title two of article eighteen-A, a new section, to be section nine hundred fourteen, to read as follows:

§ 914. St. Lawrence county industrial development agency

For the benefit of the county of St. Lawrence and the inhabitants thereof, an industrial development agency, to be known as the ST. LAWRENCE COUNTY INDUSTRIAL DEVELOPMENT AGENCY, IS hereby established for the accomplishment of any or all of the purposes specified in title one of article eighteen-A of this chapter. It shall constitute a body corporate and politic, and be perpetual in duration. It shall have the powers and duties now or hereafter conferred by title one of article eighteen-A of this chapter upon industrial development agencies and provide that the exercise of the powers by such agency with . respect to the acquisition of real property whether by purchase, condemnation or otherwise shall be limited to the corporate limits of the county of St. Lawrence, and such agency shall take into consideration the local zoning and planning regulations as well as the regional and local comprehensive land uso plans. It shall be organized in a manner preserined by and he subject to the provisions of title one of article eighteen-A of this chapter. Its members shall be appointed by the governing body of the county of St. Lawrence. The agency, its members, officers and employees and its operations and activities shall in all respects be governed by the provisions of title one of article eighteen-A of this chaptor.

§ 2. This act shall take offect immediately.

(4) The facts establishing the need for such Agency in the municipality are as follows:

To promote the economical welfare of the inhabitants and to actively promote, attract, encourage and develop an economically sound commerce and industry through governmental action for the purpose of preventing unemployment and economic deterioration by the creation of industrial development agencies and instrumentalities and to grant to such industrial development agencies the rights and powers provided in Chapter 1030 of the Laws of 1969.
