## AUTHORIZING APPLICATION FOR GRANT FUNDS THROUGH THE NORTHERN BORDER REGIONAL COMMISSION

**WHEREAS,** the St. Lawrence County Industrial Development Agency Local Development Corporation seeks to undertake a certain project (the "Project") consisting of improvements to a railroad spur located at or near 4921 Route 58N in the Town of Gouverneur, along with the rehabilitation of the railroad bridge over the Oswegatchie River, and

**WHEREAS**, Northern Border Regional Commission ("NBRC") has a competitive opportunity to apply for funding for the purpose of assisting such projects, and

**WHEREAS,** NBRC grant funding, if awarded, would provide \$494,400 in funding to enable the necessary repairs and rehabilitation to the railroad spur, and

WHEREAS, repaired spur would assist in the operations of the Dunn Paper – Natural Dam, Inc. facility and would provide opportunity for additional economic development activities along the spur, including on a parcel owned by the Town of Gouverneur identified as a location for potential future industrial development use, and

**NOW, THEREFORE, BE IT RESOLVED,** that the St. Lawrence County Industrial Development Agency Local Development Corporation authorizes preparation, execution, and delivery to NBRC of an application in the amount of \$494,400 for the NBRC Economic and Infrastructure Development Grant Program, and

**BE IT FURTHER RESOLVED** that St. Lawrence County Industrial Development Agency Local Development Corporation officers, subject to Legal Counsel opinion, each hereby designated, authorized, empowered, and directed to execute and deliver any and all grant agreements necessary to effectuate the transactions contemplated by this resolution. <a href="Patrick Kelly, Chief Executive Officer">Patrick Kelly, Chief Executive Officer</a>, will be the Authorized Official to sign Project documents \*.
