WHEREAS, the St. Lawrence County Industrial Development Agency ("SLCIDA") supports the redevelopment of the former manufacturing facility (the "Project") and recognizes the importance of the Project toward creating economic development opportunities in the County; and

WHEREAS, The SLCIDA has been awarded \$500,219.05 in grant funding under the 2016 NYSDOT Passenger & Freight Rail Assistance Program; and

WHEREAS, as outlined in a Request for Qualifications (RFQ) for selection of a Railroad Engineering Consultant the SLCIDA performed in 2022, the SLCIDA is securing the services of

Erdman, Anthony and Associates, Inc. ("Erdman Anthony") as outlined in the Attached Proposal.

NOW, THEREFORE, BE IT RESOLVED that the St. Lawrence County Industrial Development Agency authorizes the preparation, execution, and delivery of all necessary documents for engineering with Erdman Anthony in an amount not to exceed \$79,270, to be paid from the proceeds of the grant, and

BE IT FURTHER RESOLVED that St. Lawrence County Industrial Development Agency officers are, subject to Legal Counsel's opinion, each hereby designated, authorized, empowered, and directed to execute and deliver any and all agreements necessary to effectuate the transactions contemplated by this resolution.
