The contractor will trim grass along the edge and clean the entire Blacktop area to ensure it is free of debris and foreign matter.

All cracks greater than 1/8" are to be blown out to remove loose debris and filled with Hot Asphalt Sealant: (Examples of crack sealants are Crafco Roadsaver, Polyflex and Asphalt Rubber hot-applied sealants.)

Any areas affected by petroleum staining must be treated and sealed.

Re-apply line striping and markings to match existing layout.

All materials used must meet or exceed State and Federal inspections.

A Site Plan showing the area covered by this Request for Proposal is attached.
